Spring Road Inspection Town Board Meeting Minutes April 26, 2018

Call to Order: The Pledge of Allegiance was recited and a special meeting of the New Haven Town Board was called to order at about 8:00 AM by Chair Mary Andrist. Quorum requirements were met with Supervisor Denny Beyer and Supervisor Brian Hervey also present. Also in attendance were Planning and Zoning Administrator Ann Fahy-Gust, Road Maintenance Contractor Mike Wood, and Clerk Dale Thomforde. Beyer drove the van provided by Hervey for this road inspection.

The following items were observed (in order of inspection):

1. 69th Avenue – some overhanging trees on east side. May be out of ROW.
2. 91st Street – no issues.
3. East 85th Street – some overhanging trees near Rollie Postier.
4. 60th Avenue – no issues.
5. Riverheights Court – trees in ROW on north side.
6. 120th Street – Ann will check on trailer house to see if CUP is needed. Due for rock this year.
7. West Center Street – no issues.
8. 65th Avenue – Clean out culvert and remove trees near Ellefson's. May need permission from David J. Steichen to clean out down-stream from ROW.
9. 85th Avenue – due for road rock this year. Move one end-of-road marker back from trail. May need to add markers or fence to prevent drive throughs at dead end.
10. 125th Street – New triple culverts look good. Concern raised about how low new sections of 125th Street are and they may get filled in with drifting snow, especially the west section, which is lower than the nearby field.
11. New Haven Road – Speed limit study by MnDOT is about due shortly.
12. 110th Avenue – Stumps on Fangman property where looked at. They are within the 50' ROW, but are cut off low enough not to be a problem. They may help prevent ditch erosion.
13. West 85th Street – Needs some ditch/culvert cleanup. May need some rap-rap.
14. Genoa: Hervey moved to go ahead with the Barga Inc. quote to patch 26'x22' on Exchange Avenue and install 30 ton of cold mix on the worst areas of Exchange Avenue

and Main Street, for a total price of \$15,400. Motion was seconded by Beyer. The motion passed 3-0.

15. 75th Street – Some ditch cleanout is needed.

Adjournment: With no further business before the Town Board on this Special Meeting, Chair Andrist adjourned the meeting at about 10:45 AM. A total of about 35 miles were covered during this road inspection.
