WHEREAS, a public hearing was duly held on June 14th, 2022 at the New Haven Town Hall, 9024 County Road 3 NW, Oronoco, Minnesota by the New Haven Town Board. The Board took public input on the following changes to the New Haven Township Zoning Ordinance:

Interim Use: A use that would not be appropriate generally but may be allowed with appropriate restrictions upon finding that certain conditions and criteria exist and that the use is compatible with the neighborhood. A use that does not require a significant monetary investment or the use of equipment or structures that would not generally be used for other uses allowed within the district. The permit if appropriate shall be limited with a condition to a specified date, and/ or occurrence of a particular event, at which time the permit will end. An interim use may be used in any zoning district where conditional use permit is allowed if it is deemed as appropriate by the Zoning Administrator or the Town Board.
